# From the Chairperson

Summer greetings!

I want to start by thanking you for your continued support and engagement of COIVPP activities. We know these last few months have been challenging as the environment for child injury prevention programming, advocacy, and research has substantially changed. There have been significant staff and funding cuts to the Centers for Disease Control and Prevention (CDC), the National Institutes of Health (NIH), the Food and Drug Administration (FDA), the Consumer Product Safety Commission (CPSC), and other federal

agencies. This is directly impacting the national COIVPP partnerships as well as our individual members. National programs, including programs like those focused on safe infant sleep, have essentially been eliminated. These cuts are also impacting resources and programs at the local and state level. So, it is unclear what the future holds for continuing injury prevention work and research. The AAP federal affairs team has been working hard advocating on multiple levels for these organizations and programs, and their work is ongoing. Thanks to Ami Gadhia, Nathaniel Lim, Ella Matthews, and Katie Matlin for all their injury prevention advocacy work. Thanks also to AAP President Sue Kressley and all the other members of the AAP federal and state affairs teams for their broader advocacy work. Now, more than ever, it is essential for the pediatric injury prevention community to stay committed and continue our important work for programming, research, and advocacy. We must continue to focus on the work and advocacy we can do in these times while supporting each other for the benefit of our patients and families

#### **Trainee NCE Travel Fund**

We had a successful first year with the Trainee NCE Travel Fund. We were able to provide stipends to two trainees who presented their abstracts at the NCE last year. This is a great way to support our trainees and encourage new researchers in the field of pediatric injury prevention. # Highlights from COIVPP and the AAP

Button Battery Safety was the topic of the recent T4CIP Day of Action (see section below), and because of the great information presented, we asked Dr Leah Middelburg to contribute a short piece on recent button battery product changes to keep our membership up to date on this critical topic.

#### **Button Battery Product Changes**

Though button or coin batteries are not new, they have been used in products for decades, the number of childhood injuries and fatalities due to their ingestion has significantly increased in the last 20-30 years. This dramatic rise seems to be linked to an increase in the diameter of the batteries (>/= 20mm diameter batteries) and the change to lithium cells (twice the voltage of previous batteries).

In 2022, a federal law, Reese's Law, was signed into action, which mandated a federal safety requirement for button, cell, and coin batteries. Subsequently, the CPSC established performance standards around packaging, secured battery compartments, and warning labels on all small battery products. Since that time, manufacturers have pushed to make their products appear safer. These measures include a bitter coating on the battery to deter children from placing it in their mouths and a color change coating that can dye the mouth blue after contact with saliva. However, it is unclear how effective these newer deterrents are in decreasing ingestion risk. Some questions around these innovations persist. For example, will caregivers or providers know the discoloration means a battery ingestion, what the dye substance is, and how long it takes to react? The battery-maker Energizer states that the bitter and color-change coating is good for one exposure only, and the dye is a non-toxic, food-grade substance that will react within seconds of the child's saliva interacting with the packet on the negative pole of the battery.

While any attempt at added safety is welcomed, these measures by no means make these products safe to have

within easy access of young children. The American Academy of Otolaryngology-Head and Neck Surgery position statement calls for more. "Industry must adopt a new safe button or coin cell battery technology that will not cause severe injury inside the body." Until the time batteries are redesigned in a way that they cannot cause injury when ingested, the message to families should remain: keep button batteries out of the reach of children.

# **AAP Legislative Highlights**

### **Product Safety & Injury Prevention**

In March, the U.S. Court of Appeals for the Tenth Circuit upheld federal safety standards regulating high-power magnets and affirming the Consumer Product Safety Commission's (CPSC) authority to regulate small, powerful magnet sets that are dangerous health risks to children if ingested. The AAP's brief was cited in the court's opinion in footnote 8, where the court stated, "Indeed, medical experts note that such ingestions "cause life-threatening injuries to children," and describe magnet ingestion as "a pediatric healthcare crisis."" In August 2023, the AAP joined other medical organizations in submitting an amicus brief to defend these safety standards for magnets and urged the court to uphold CPSC's necessary and evidence-based rule on high-powered magnets in order to prevent serious injuries and save lives.

In May, the AAP signed a **letter** to Congress supporting maternal and infant health programs, including the Safe to Sleep Campaign, which has helped reduce infant mortality rates nationwide, and the Sudden Unexpected Infant Death and Sudden Death in the Young Case Registry, which helps researchers and medical professionals prevent infant deaths by gathering, analyzing, and sharing the data needed to develop strategies and interventions.

#### **Gun Violence Prevention**

The AAP continues its work leading the medical, public health, and research community's advocacy for federally funded research to prevent firearm violence through the **Gun Violence Prevention Research Roundtable** coalition. The AAP recently sent a letter of over 400 medical, public health, and research organizations **calling on Congress to maintain and increase gun violence prevention research funding**. The continuing resolution for FY 2025 allows for the continued level funding of \$25 million for firearm violence prevention research, split evenly between the Centers for Disease Control and Prevention (CDC) and the

National Institutes of Health (NIH). The AAP is continuing its efforts to make clear the importance of at least maintaining this current funding for FY 2026.

The AAP is also continuing to engage in a strategy to elevate pediatrician stories about gun violence to drive policy change, including a **partnership with StoryCorps**. The AAP's Firearm Injury Prevention Special Interest Group (SIG) also continues to hold events throughout the year to engage our members on firearm violence prevention efforts.

## **Liaison Report**

# **Canadian Paediatric Society (CPS)**

The Canadian Paediatric Society Injury Prevention Committee has been engaged in the following activities since the last update:

#### **Position Statements:**

Published statement - posted to CPS website Feb 24, 2025. "Off-road vehicle use by children and adolescents: Strategies to prevent injury" https://cps.ca/en/documents/position/off-road-vehicle-use and has been translated for publication in the journal Paediatrics & Child Health. The release of the statement garnered national media interest from CBC Syndicate with radio interviews conducted across the country, as well as national televised news coverage. The CPS has engaged with a number of provincial government Ministries of Transportation to discuss how these recommendations can be actioned. Additionally, the Ontario Coroners Office is collaborating to embed the recommendations within their independent review. The position statement will be highlighted through a presentation at the 2025 CPS Scientific Assembly in Quebec City.

In development – there are two statements currently in development. The statement "Reducing Harm, Promoting Health: A Framework for Paediatric Injury Prevention in Canada" will act as a foundational document that can be kept evergreen for referencing and education. This statement is completed and will be submitted for review shortly. The second statement being written is focusing on pediatric burn prevention and will be submitted in the fall of 2025.

# Canadian Paediatric Surveillance Program One-Time Surveys:

The committee is engaged in 3 separate surveys which have undergone review and have been approved for distribution. These include national one-time research surveys to pediatric healthcare providers across Canada addressing the increasing use of micromobility devices such as e-scooters and e-bicycles, falls from height

resulting in significant injury, and severe trampoline injuries.

# **Committee Membership Change:**

The CPS Injury Prevention Committee's current membership resumed in 2019 and has been a force in developing and implementing our IP initiatives and profile at the CPS and across the country. There will however be some switching of membership this June. As Chair, my term is ending and I will be stepping away with Dr Daniel Rosenfield from SickKids taking my place. It's been an incredible pleasure to lead and work with this committee, and an honor to be the CPS liaison for COIVPP through these years. I have learned a great deal from the amazing passion and dedication every member of these committees demonstrates.

# **Prevent Child Injury and Trainees for Child Injury Prevention (T4CIP)**

Trainees for Child Injury Prevention (T4CIP) is a group of trainees from across the country committed to child injury prevention that develops outreach materials and strategies for one-day national advocacy campaigns. This core group of trainees reaches out to other trainees and training programs asking them to participate in each Day of Action by sharing information during their morning report, noon conference, or continuity clinic, as well as sharing information on social media. T4CIP is sponsored by the Center for Injury Research and Policy in Columbus, Ohio, and the American Academy of Pediatrics Section on Pediatric Trainees and Council on Injury, Violence, and Poison Prevention and is supported, in part, by funding from the Centers for Disease Control and Prevention (CDC). Staff from AAP Media and Outreach are also closely involved.

In January 2025, the fifth year of the program launched with 81 trainees – including 41 medical students, 31 residents, and 9 fellows. Participants come from 53 institutions in 30 states. We also have 11 facilitators and 75 T4CIP trainee alumni who wanted to continue with the program through the alumni committee.

The ninth Day of Action was on May 21, 2025 and focused on button battery safety. You can search the hashtag #ButtonBatterySafety on X, Instagram, and LinkedIn to see some of the great posts from participants and partners. The May 2025 Day of Action had nearly 815,000 impressions from over 300 posts across social media. Watch this one-hour webinar that T4CIP co-hosted with Prevent Child Injury, with 270 views and counting, moderated by Dr Gary Smith (Nationwide Children's), with panelists Dr Kris Jatana (Nationwide Children's), Jonathan Midgett, PhD (US CPSC), and Trista Hamsmith (Reese's Purpose). You can view all the #ButtonBatterySafety graphics and outreach materials on T4CIP's website. Social media graphics are available in two sizes, and in English and Spanish.

Trainees also organized and participated in local advocacy and community partnerships, including working with their AAP chapters and Safe Kids coalitions. They gave talks to their colleagues and peers and created and distributed educational materials to families. They wrote features for newsletters, were guests on podcasts, and were interviewed for local news stories.

T4CIP's next Day of Action will be on October 22, 2025, and will focus on medication safe storage. 
